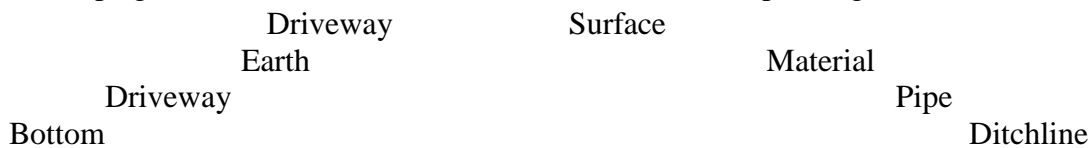

The following conditions must be met regarding new or existing driveways:

1. Driveway side slopes shall be earth material covered with black ground and seeded.
2. No concrete or bituminous side slope will be allowed.
3. Side slope grade shall be no less than three (3) to one (1) as per diagram:



4. No concrete or concrete slip in or on Right-of-Way.
5. Driveway surface must be a flexible material (asphalt or gravel).
6. Culvert must be a minimum of five (5) feet from property line and at right angles to the roadway.
7. Driveway surface shall be: _____ (____) feet in width.
8. The driveway pipe required: _____ (____) diameter and _____ (____) feet long.
9. Apron end walls may be used in lieu of cutting pipe.
10. When the project is started, work must be completed within 60 days with all conditions met.
11. Please, notify the Chairperson within five (5) days of the completion of the above-described project.
12. This application is for the project described above and it is not a permit for any other improvement.
13. Blacktopping of driveways graded so that the water is diverted to the sides and not drained onto the roadways maintained by Town of Maple Grove, low enough to avoid issues with snow removal.
