**First Saturday and Third Saturday of the month 9:00 AM to 4:00 PM**

## **RECYCLABLE RESOURCES AND SOLID WASTE INFORMATION**

### **Preparation and Separation of Resources for Recycling:**

- 1. Aluminum-made: Cans, Foil Wrap, Food Trays and Pie Pans and Siding** clean well and flatten.
- 2. Cans (tin, steel, bi-metal, aluminum, coated)** clean well, remove labels and flatten.
- 3. Cardboard (brown corrugated inside when torn)** clean well, dry, flatten and boxed, bagged, or bundled. Note: sort brown paper bags with cardboard.  
**Reminder** plastic, tin, and/or wax coated cardboard and white board or gray board NOT accepted for recycling.
- 4. Glass (amber, blue, clear, green)** clean well, remove labels/rings and separate by color.

**Reminder** ceramic/clay-based items, drinking glasses, light bulbs, and window glass NOT accepted for recycling.

**5. Magazines, Newspaper, and Brochures** clean, dry, staples removed and boxed, bagged or bundled.

**6. Plastic Bottles/Containers** marked as No. 1 and No. 2, clean well, remove caps/rings/labels and flatten.

**Reminder** motor oil and cooking oil bottles and containers NOT accepted for recycling.

**7. Used Oil** in closed containers accepted for recycling.

### **Solid Waste Disposal:**

**1. Ashes** cold and enclosed in CLEAR bag and received during months of March through October.

**2. Garbage/Trash/Waste** enclosed in CLEAR bag.

**Reminder** all solid waste enclosed in CLEAR bag.

**3. Fees Assessed by the Transfer Station Attendants** \$3.00 per bag, \$6.00 per barrel, \$20.00 for a small pick-up truck load, and \$30.00 per large pick-up

truck load. Attendants assess an additional monetary charge for solid waste materials not in CLEAR bags.

- 4. Computers** received by the Manitowoc County Material Recovery Facility 3000 Basswood Road, Manitowoc (920) 683-4333 for schedule, information, and recovery for CPUs, monitors, printers, keyboards, laptops, modems, mouse, storage drives, terminals, mainframes, and other components.

**5. Heavy and/or Large Items** include air conditioners, boilers, carpet, cement decorations and vases , chairs, clothes dryers, clothes washers, dehumidifiers, dishwashers, drywall, fiberglass and foam insulation, flooring, freezers, furniture, furnaces, humidifiers, mattresses, ovens, refrigerators, shingles, sofas, stoves, swimming pools, televisions, toilet bowls, vinyl siding, water heaters and water softeners; and, this list is not definitive. ### **Vegetative and/or Organic Materials from Yards**

Have a plan for what to do with grass and lawn clippings, leaves, garden debris, woody vegetative materials, roots, shrubs with intact root balls, branches, tree trunks, stumps, and brush that involves composting. Above materials from residential yards, farm yards, and/or business yards NOT accepted at the Transfer Station and BANNED in all road right-a-ways.

## Management with For Hire Haulers

Deciding what to do with old or used ag and/or plastic containers, ag film, fiberglass and foam building materials, plastics and non-recoverable components used in farms, businesses and households can be difficult. Town of Maple Grove residents and/or business owners have responsibility to contract with haulers of their choice for scheduled materials management services. **Burning plastics, other petroleum-based materials and most other garbage materials - whether in the open or in burn barrels or containers - is illegal in Wisconsin under ss. NR 429.04 and NR 502.11 Wis. Adm. Code.** Also, all materials placed into a hauler's recycling or waste containers belong to that business, waiting for the scheduled pickup. **Personal dumping at the Transfer Station when closed and Attendants are not present is not nice.** Per Recycling Ordinance 1.22 persons who violate may be required to forfeit no less than \$25.00 or no more than \$500.00 for subsequent violations.
